Qualification for alimony (aka “maintenance”) - §8.002, TFC:

1. Payor was convicted of a crime of family violence two years or less prior to the filing of the divorce (or while the divorce is pending), or

2. the parties have been married for at least ten years, and the Payee doesn’t have much property and has an incapacitating physical or mental disability which prevents him from getting a job; or has custody of a child who needs intensive care such that he can’t have a job; or he clearly lacks earning ability in the labor market.
